### **1.0 PREAMBLE**

The establishment of the School of Continuing Education was proposed by the University Management at its Regular meeting held on 20<sup>th</sup> May, 2021. The proposal was approved by the Senate of Umaru Musa Yar'adua University, Katsina at its 108<sup>th</sup> Meeting held on 2<sup>nd</sup> June 2021. The decision of the Senate was ratified by the University Governing Council at its 47<sup>th</sup> meeting held on Thursday, 6<sup>th</sup> January, 2022 in accordance with the provision of Part VI Section 22 (a) & (b) of the University Law.

The University Management had, sequel to the Council approval, constituted a take up committee of Nine (9) and saddled it with the responsibility of running the affairs of the School. The Committee was later metamorphosed into the School Management Committee which was in accordance with the provision of Section 10.1 of the Statute establishing the School with composition as follows:

### **3.4 Duration of Studies**

## **4.0 ADMISSION REQUIREMENTS**

### **4.1 100 Level Entry Requirements**

For admission into 100 Level, candidate should possess a Senior Secondary School Certificate (SSCE; NECO; NABTEB) or its equivalent with a minimum of five (5) credits including Mathematics and English Language obtained in not more than two (2) sittings.

### **4.2 Direct Entry Candidates**

The following candidates shall qualify for Direct Entry into Level 200:

- i. In addition to the above O'level requirements, holders of National Certificate of Education (NCE) with a minimum of nine (9) points or Diploma with a minimum of Lower Credit pass or its equivalent in relevant certificates obtained from recognized institutions;
- ii. All applications shall be subjected to a selection process.
